TREASURY DEBT BUYBACK OPERATION RESULTS

Today, Treasury completed a debt buyback (redemption) operation for \$1,500 million par of its outstanding issues. A total of 12 issues maturing between November 2022 and November 2027 were eligible for this operation. The settlement date for this operation will be December 17, 2001. Summary results of this operation are presented below.
